Committee Chair must notify City Clerk at least 24 hours in advance of a meeting cancelation or rescheduling.
- ➤ Each Chair will designate a member to take notes and prepare a written report of the discussion and recommendations which are to be presented to the full Council by the Committee Chair at the next City Council Meeting for Council consideration. Original to be sent to City Clerk for official record.
