## Minutes Architectural Review Board Meeting Wednesday, September 21, 2016 5:15pm Council Chambers, City Hall 100 East Carolina Avenue

Chairman Bobby Goodson called the meeting to order at 5:27pm. He then presented the August 2016 minutes for approval. Bob Brown made a motion to approve the minutes as submitted. Bobby Goodson seconded. All in favor.

## Mahala Reese – 113 N. Fifth St. – window and door signs

Amy Owen was present to participate in the discussion regarding her request for signs on the front doors and the side door. The signs would include the logo and business name. The door on the left would include hours and days of operation. The right door would include the web address. Mrs. Owen also presented colors for the building (requisite gray SW7029), the building trim (downy SW7002), and the door trim (black magic SW 6991). Mrs. Owen would also put up paper in the windows with her name and logo as the interior work is completed and prior to opening. Nic Ison made a motion to approve the proposal as submitted. Fletcher Bateman seconded. All in favor.

## ReMax Realty – 122 N. Fifth St. – wall and projecting signs

Christopher Williams was present to participate in the discussion regarding his request for a wallmounted, window, door and projecting sign. The wall mounted sign would be made up of individual letters adhered to the face of the building. There would be no internal nor external lighting. The total signage exceeds the allowable signage. Mr. Williams would have to make a decision about what sign/s to eliminate. Mr. Williams said he would eliminate the projecting sign. Mr. Williams said that although he was presenting the signs, the signs would not be installed at least for a couple of months because ReMax is going through a rebranding that will take a minimum of 45 days before completion. According to Mr. Williams, the logo will change and the color scheme and the size will remain the same. In addition to permanent signs, Mr. Williams also requested a 90-day banner. Bob Brown made a motion to approve the signs as submitted not including the projecting sign. Nic Ison seconded. All in favor.
