BCAC is applying for funding for a series of events held annually by the Arts Council. These events all promote our City as a beacon of entertainment in the area of unique arts-related shows and programming.

In recent years, BCAC has been extremely successful in event planning and implementation. This has led tourists to Hartsville. BCAC plans its cultural calendar around Hartsville's events which provides a cultural attraction for visitors to our area. By providing this service to our visitors it encourages them to come to our area, stay in our hotels, shop in our stores, eat in our restaurants and come back year after year.

As we move forward in our 45 plus years as an organization, BCAC continues to strive to promote the uniqueness of the area we serve. Our attention still focuses on promoting Hartsville as a destination (for both day-trippers and vacationers) to the Pee Dee region and entire State of South Carolina. In a study by Princeton University, 39% of all adults voluntarily attend at least one art activity in a 12 month time period.

## A. BCAC - History and Goals

In 1967 the Hartsville Arts Council was organized by cooperating with the Hartsville Building Commission, the Center Theater was renovated for performing arts. In 1986 Hartsville Arts Council revised its by-laws and the name was changed to Black Creek Arts Council. In 1998 a strategic plan was created with the goal in mind to create a Center for the Arts. After a capital campaign to raise the needed funds, the Hartsville Community Market a National Historic Register site was renovated to house Black Creek Arts Center which encompasses an art gallery, classrooms, artist studios, offices and meeting space.

In 2002 Black Creek Arts Center was opened to the public, with the mission to promote and foster the Arts in Darlington County. Black Creek Arts Council is dedicated to providing guidance and assistance in arts administration, funding, education, and program coordination to arts-based organizations and artists in Darlington County. The Council offers a variety of arts classes and produces numerous arts-based events and festivals.

  proven to consistently be a mutually rewarding program for both
  organizations, as well as the students we both aim to serve.
- BCAC operates a subgranting program that funds programs and projects by arts-presenting non-profit organizations and individual artists in Darlington County.
- BCAC offers classes and weekend workshops throughout the year, as well as Summer Art Camps. Classes and workshops are offered in all mediums.
- BCAC has a wide variety of rental options for parties, receptions, meetings, workshops, luncheons, and more. The Arts Center has four different spaces for rent.

## C. BCAC - Proposed Project

The Subgranting Program is beneficial to BCAC in that it speaks directly to our mission of promoting and fostering the Arts in Darlington County. Through this program, we enable other organizations or artists to achieve their goals and missions. Black Creek Arts Council operates a subgranting program that funds programs and projects by arts-presenting non-profit organizations and individual artists in Darlington County. This program has been one of BCAC's largest programs since 2002.

#### D. BCAC - Program Benefits

BCAC serves as an umbrella organization for the arts in Darlington County. Darlington County is a poor, rural county in the Pee Dee region. We are the primary financial and consultative resource for many arts-presenting and performing organizations, as well as cultural organizations and individual artists. BCAC also provides programming assistance for emerging or struggling organizations. With corporate support, our subgranting program allows us to assist a broad range of organizations and bring a variety of arts-based programs into our county.

#### F. BCAC - Evaluation Plan

The applications are accepted according to the schedule and reviewed by the Executive Director, who then meets with the grant panel for distribution. The Panel consists of a chairperson and seven (7) committee members, representing the community, area businesses and the arts. The committee makes their award recommendation based on a review criteria checklist. The recommendations are presented to BCAC's Board by the Panel chairperson and get voted on for approval. Panel members must submit a checklist with each grant reviewed. A letter will notify Recipients as soon as possible after a decision has been reached by BCAC. Recipients will receive one-half of the grant at that time. The balance of the funding will be forwarded when the recipient's submission of the Final Evaluation and Fiscal Report due thirty (30) days after the project.

#### G. BCAC - Impact

Darlington County is a relatively poor, rural county and this program exposes our community to an array of artistic mediums. Community leaders and subgrant recipients feel it has a major impact on a majority of the area population. In an effort to expose the community to a range of arts disciplines, we fund performances and readings, coordination of arts events, workshops and artist residencies, services to artists and organizations and artistic exhibitions.



## H. BCAC - Additional Funding

BCAC's Subgranting program is funded in part by: Sonoco Foundation South Carolina Arts Corporate and Business

## BCAC – Past Funding Summarize funded activities:

In FY16, BCAC received 10 requests for funds equaling \$30,700. BCAC was able to partially fund all programs and achieve diverse audiences to benefit from our subgranting program. The events ranged from free chorale performances, incorporating a wide range of ages performing and as audience members to an inaugural Plein Air competition. BCAC did not have any individual artists apply to the subgrant program in FY16.

The artistic component for the Main Street Hartsville was funded, providing a series of FREE concerts on East and West Carolina Ave and College Ave. The Friends of Darlington County Library annually submits a grant request to fund their summer reading/performance which takes place at each branch of DC library system. This event is free to the public and very well received by the community. RenoFest, the second largest tourism event in Darlington County is a Bluegrass Concert and Competition which takes place the 4<sup>th</sup> weekend in March. This year was the 19<sup>th</sup> year for this award winning event <a href="http://www.renofest.com/home.html">http://www.renofest.com/home.html</a>. We were extremely pleased to once again partner with South Carolina African American Heritage Foundation, which gives BCAC an opportunity to better serve the African American community, and we were able to aid them in funding Gospel in the Park as well as bringing Ron and Natalie Diase to perform God's Trombones. The performance of Gods Trombones performed for more than 400 attendees at the Hartsville Center Theater and 800 elementary students.

A schedule of events and information on participating artists/consultants:



**Gospel in the Park** – is a series of events held yearly from May-October showcasing local and nationally known gospel artists in an effort to bring the community together. This year's event featured 35 artists to an audience of over 3000.

Main Street Hartsville Concerts – September – October 2015, A Main Street Hartsville event designed to highlight local musical talent. This program featured 8 artists and approximately 1000 audience members. BCAC funded one of these performances.

Hartsville Community Players – Columbia City Ballet's *The Nutcracker*, the sole purpose of this project was to bring additional artistic and educational opportunities o the youth and citizens of our community. Due to current economic times attending arts events has often been a stretch for families. This project made performing arts more accessible to the general public and allowed area children to perform and learn alongside a world-renown ballet company. There were 77 artists and approximately 2500 attendees.

Hartsville Community Development Foundation – Columbia Children's Theatre 3 programs – Jingle Arrgh! The Way in December, Elephant & Piggies "We Are In A Play" in March and Seussical the Musical in May. This event features approximately 36 artists and an audience of 9000.

**SC African Heritage Foundation -** On Sunday, February 21, 2016 the South Carolina African American Heritage Foundation presented Ron and Natalie Daise in their presentation of God's Trombones at the Center Theater, 212 North 5th Street, Hartsville, SC.

We used the occasion of Black History Month to present the performance at the Center Theatre in Hartsville, SC on February 21 and followed-up with a session at Spaulding Middle School in Lamar. The performance was attended by nearly 300 people who included families in the "Family Strengthening Program" of Darlington and Lee Counties. "God's Trombones" was a major part of black culture at one time. Children and adults learned and presented the poetry of James Weldon Johnson at church, school, and civic events. The theatrical performance of James Weldon Johnson's "God's Trombones: Seven Negro Poems in Verse" includes a cappella selections of Gullah spirituals and appeals to lovers of inspirational writing, scholars of African American culture, and persons who appreciate great poetry inspired me early in life to be transformative in onstage presentations.



**RenoFest** – Always the 4<sup>th</sup> weekend in March – 19<sup>th</sup> year. This event is a music festival featuring a form of music known alternative as Americana, folk, old time, old country and most frequently bluegrass, named after one of the greatest bluegrass musicians of all time, South Carolinas, Don Reno. This event features approximately 125 artists and an audience of 2500.

**Hartsville Community Chorus** – *Mass of the Children & Schafer Mass in A* – May 2016 based on attendance 250+ audience members, 60 area adults and students plus 30 professionals. The participation and audience serve as further evaluations of how the community values the efforts of the organization.

Art in the Gardens – Kalmia Gardens Plein Air Quick Draw Competition – Saturday April 8, Artists from the Pee Dee region were invited to participate in the competition with awards given at the exhibition at Black Creek Arts Council for the month of May. 11 area artists participated and approximately 500 people attended the competition and exhibit. Due to weather the competition was postponed until the following weekend which coincided with Kalmia Gardens Earth Day celebration, due to the overwhelming response from attendees, this event will become an annual event and always take place on Earth Day.
