Public Housing Updates: The Delinquency Report Rating was at 100%. The Public Housing Waiting List stands at 28 applicants. Move-outs: 5.

Section 8 Updates: The Delinquency Report Rating was 100% as of October 31, 2016. The Waiting List stands at 80 applicants. No move outs. New admissions: 0. Occupancy rate: 168

Installation of dryer connections is complete.

HUD completed a Limited Management Review on September 28 – 30, 2016. Keith Landrum with HUD conducted the review which was composed of compliance with civil rights regulations particularly as it relates to Section 504 of the Rehabilitation Act, evaluate the Authority's compliance with HUD's Section 3 program, evaluate the authority's compliance with general HUD program requirements and assess the condition of the Authority's developments and selected units. The Authority passed all except Section 3. The Authority needs to implement procedures to notify Section 3 residents or business concerns about the program. The Authority has developed procedures which is a part of the meeting agenda for board approval.
