PRESENTATIONS

Recognition of New Hires/Promotions: Mary Catherine Farrell introduced Holden Bennett, Chief Building Official and supervisor of the Business Navigator staff.

Proclamations: The General Aviation Week proclamation was presented to pilot Sandi Brown and FBO Hemming Hemmingsen. They thanked Council and expressed the desire to continue to grow the airport for economic development and to assist with business needs, especially flying in industrial/nuclear parts in an emergency.

Main Street Inspiration Award - Beppie LeGrand, Main Street Manager, praised Hartsville for their vision and enthusiasm in creating a vibrant downtown atmosphere. She presented the Main Street Inspiration Award for "outstanding public/private partnership" to Suzy Moyd, Main Street Hartsville Director and the Mayor and Council.

MASC Achievement Award - Bill Taylor, Field Services Manager, called Hartsville a shining star after the video was shown highlighting Startsville, StartUp Hartsville, and the Business Navigator for the award in the 5,001-10,000 category for downtown revitalization.
