FINAL READING ORDINANCE 4337: AN ORDINANCE TO AMEND THE WATER AND SEWER RATE STRUCTURE IN ACCORDANCE WITH SECTION 82-176(a) OF THE HARTSVILLE CITY CODE – APPROVED.

Approval of Final Reading and Waiving of Complete Reading: Motion: Andrews; Second: Shirley; Motion made by Andrews to amend Ordinance 4337 to reflect Section C as residential water customers minimum charges based on size of meter and Section D as non-Residential Water customers minimum charges based on size of meter and by adding Section E for Residential Sewer customers minimum charges based on size of meter and Section F for Non-residential Sewer customers minimum charges based on size of meter with a slight decrease in water and sewer rates for 1 and 1 ½ inch metered residential customers.

Second: Gammage; Amendment Carried with all ayes. Motion to approve as amended: Andrews; Second: Gammage; Carried: with all ayes except Mack who voted nay.
