RESOLUTION 2018-2019

A RESOLUTION AUTHORIZING THE BISHOPVILLE POLICE DEPARTMENT TO ENTER INTO MULTI-JURISDICTIONAL AGREEMENTS WITH VARIOUS LAW ENFORCEMENT AGENCIES AND AUTHORIZING THE CHIEF OF POLICE OF THE CITY OF BISHOPVILLE AND THE CITY ADMINISTRATOR OF THE CITY OF BISHOPVILLE TO APPROVE AND SIGN MATERIALLY EQUIVALENT AGREEMENTS ENTERED INTO BY THE POLICE DEPARTMENT IN THE FUTURE.

WHEREAS, as amended on June 3, 2016, South Carolina Code Ann. 23-20-10, et seq., provides for contractual agreements between and among state, county, municipal and local law enforcement agencies for the purpose of providing the proper and prudent exercise of public safety functions across jurisdictional lines;

WHEREAS, Section 23-20-40 of the South Carolina Code of Laws sets out required contractual provisions for such contracts between law enforcement providers;

WHEREAS, the police department for the City of Bishopville, in recognition of the need to promote public safety through the careful coordination with law enforcement agencies throughout the areas surrounding the City of Bishopville, has proposed entering into contractual agreements with law enforcement providers throughout our area which are proper and prudent in the exercise of public safety functions, copies of all such proposed agreements being attached hereto and specifically incorporated herein by reference; and

WHEREAS, the City Council of The City of Bishopville, South Carolina, having reviewed all of the agreements attached hereto, concludes that the agreements are in the best interest of the citizens of the City of Bishopville and the citizens of the surrounding areas, and that these agreements will promote public safety and are needed to maintain public peace and welfare.

NOW, THEREFORE, BE IT RESOLVED that the Administrator and City Council of the City of Bishopville, at a duly assembled meeting of said City Council:

1. Hereby specifically approve and authorize all of the proposed multi-jurisdictional agreements proposed currently by the Bishopville Police Department and attached hereto with law enforcement agencies listed as follows:
