Applications

Retrofit Sip & Seat – 114 S. Fourth St. – fascia, handrails, deck & landscape plan

Brandy Stellingworth were present to participate in the discussion regarding the application. Mrs. Stellingworth presented the request for copper fascia, black metal handrails on the three entrance doors, a wooden deck on the rear, and a landscape plan that included a pebble stone ground cover, a path from the parking lot to the entrance, concrete pavers from the pathway to Fourth Street, a fire pit, and synthetic boxwoods and concrete planters. Because of the number of items presented, the board elected to vote on the items separately. Wingfield made a motion to approve the fascia as submitted; Second: Rogers. Carried: All in favor. Rogers made a motion to approve the black, metal handrails as submitted: Second: Wingfield. Carried: All in favor. Wingfield made a motion to approve the deck as submitted: Seconded: Rogers. Carried: All in favor. Rogers made a motion to approve the pebble stone ground cover, the boxwoods and concrete planters as submitted: Seconded: Wingfield. Carried: All in favor. Coldwell Banker – 152 E. Carolina Ave. – window sign
