Mayor Hancock called the meeting to order at 5:32pm and asked Councilmember Mack to lead in the invocation and Pledge of Allegiance

MOTION TO WAIVE READING OF AND APPROVE THE MINUTES OF THE JANUARY 11, 2022 CITY COUNCIL REGULAR MEETING AND THE JANUARY 14, 2022 SPECIAL CITY COUNCIL MEETING – APPROVED.

PRESENTATIONS

Public Comments:

- a. Carol Ann Godwin, 308 East Richardson Circle: Owner of commercial rental property stated that the application for business license was not applicable to her. She explained that she thinks this is taxing the same building twice and asked Council to amend the business license section of the code and make an exemption for commercial property.
- b. Belinda Copeland, 503 West College Avenue: She Stated that she owns and rents (for a little income) the building the Free Medical Clinic occupies. She complained that there was no explanation before receiving the letter regarding business license.
- c. Daniel Moore, City Manager: Ordinance 4422 The State wanted to unify all business license codes across the state. State classifies a business as income, including income from residential or commercial rent. We looked at other cities and they make no exceptions; we do on a case-by-case basis when discussed with the Business Navigator staff based current policy.

Proclamations:

Black History Month: Read and presented to City Clerk for the record.

Brigadier General Jackson: Presented to Bennet Gore to send to Washington for a presentation there to Brigadier General Jackie Thompson Day in Hartsville. He is only the second African-American to be promoted to this rank in the 247 year history of the United States Army's JAG Corps.

Franklin Hines Sympathy: Mayor asked for a moment of silence in memory of former Councilmember Franklin Hines and then presented the proclamation to Councilmember Caldwell to provide to Mr. Hines family.

- a. Annual SC Ethics SEI Filing deadline 3/30/22
- b. Katie Anderson was introduced as the new Operations Manager at Neptune Island Waterpark She previously worked two seasons at the waterpark.
- c. Hartsville Public Development Corporation voted unanimously to revise by-laws to allow the Mayor Pro-tem and Councilmember from District #1 to be the ex-officio Council appointed members. The RFQ process is in the works.

- a. Kim Rush from 400 McLeod is against this ordinance citing safety issues in the downtown as customers exit businesses and other pedestrians walk along the sidewalks. Sidewalks need to be safe and slow as people come here to spend their money.
- b. DeLaine: Let's see how it works out.
- c. McGee: This won't immediately flood our sidewalks. B-1 district on the fringes are not as safe.
- d. Mack: We asked for input and we took our time before passing this and it can be amended if we need to. There is no information available to not pass it.
- e. Andrews: Not ready for this on downtown sidewalks. It's a hazard. In favor of outside the B-1. Approval of Final Reading and Waiving of Complete Reading: Motion: McGee; Second: Caldwell; Carried: All ayes, except Andrews voting nay.
