ORDINANCE 4433

TO AMEND CHAPTER 70 "SOLID WASTE" ARTICLE I "IN GENERAL" SECTION 70-3 "COMMERICAL SOLID WASTE USER'S FEE."

WHEREAS, the city operates as a service to the citizens of Hartsville a solid waste program that is responsible for the collection and disposal of garbage, waste matter and yard debris; and

WHEREAS, sound financial management dictates that the rate structure for commercial solid waste user's needs to remain in effect as shown below until revised by Ordinance of City Council.

NOW, THEREFORE BE IT BE ORDAINED, by the Mayor and City Council of the City Hartsville that the following rate schedules are hereby adopted and upon final passage the 2022/2023 rates will become effective with the July 2022 billing that is due on August 15, 2022 and the FY 2023/2024 through 2026/2027 rates will become effective July 1st of their respective years.
