RESOLUTION 09-22-06: APPROVAL OF REVISION TO HARTSVILLE CROSSING PLANNED DEVELOPMENT STANDARDS - APPROVED.

Discussion: City Manager explained the shopping center 2001 development standards dictated earth tones. Wal-Mart requesting new paint colors with Wal-Mart blue for wayfinding. Approval of the request could trigger a domino effect with other entities requesting a change too. Additional requests would follow the same process with review by Planning Commission followed by a resolution for Council's consideration.
