# **Public Comments**

Frank Fowler, 201 Barefoot Street: suggested establishing a site for residents to drop off pine straw and leaves as an alternative to the new yard debris plan requiring the use of rollcarts or bags as this is difficult for older residents. Requested City's help to identify whether the property owners, City, State or Duke Energy are responsible for trimming tree limbs off the power lines on Green Street and Barefoot Street.

Clyde Stuckey, 310 Law Street: asked for help to further understand the reasons behind the changes to the yard debris program and requested a meeting to discuss the program.

Scott Wilds, 206 Fairfield Terrace: expressed interest in evolution of decision to change yard debris pick-up, how the City chose this option and why the change is necessary.
