Mayor Pennington called the meeting to order at 5:10pm and asked Councilmember Mack to lead in the invocation and Pledge of Allegiance.

MOTION TO WAIVE READING OF AND APPROVE MINUTES OF OCTOBER 10, 2017 REGULAR CITY COUNCIL MEETING - APPROVED.

PRESENTATIONS

COMBINED UTILITY/WATER PARK FEASIBILITY STUDY - Peiffer Brandt, President and Chief Executive Officer for Raftelis Financial Consultants, Inc. and Dan Martin of Market & Feasibility Advisors, LLC (via phone) presented to Council on their respective financial and market feasibility reports for the water and sewer utility and water park.

The water rate assumptions are based on less water use over time due to newer, more efficient equipment and household products and declining/static population in the City's service area. Despite these limiting factors, the City has not changed water and sewer rates in several years. The Raftelis report assumes a 3% water and sewer rate increase over the next five years; this accounts for inflation factors, reduced customer demand, pay as you go projects and maintaining of existing utility fund transfers. Actual rate adjustments necessary to cover these costs could be different. A true rate study is anticipated and will need to be conducted to establish actual rate adjustments going forward. If rates stay the same as they are now, you lose the effect of compounding and every year of deferred rate increase results in an inability to meet projected costs - this is regardless of whether the waterpark is on line or not. Based on the waterfall of funds under the City's new master bond ordinance, debt service expenses on the 2015 Revenue Bonds are paid first, then operating and maintenance costs of the water and sewer utility; then the depreciation and contingent funds for the utility system; then any surplus utility revenues are mixed with water park revenues and used to pay operating costs on the water park, then you pay debt service on the water park bonds, then depreciation and contingency for the system and finally fund transfers. The proposed bonds are payable from the combined system, meaning that water, sewer and water park rates must be raised to cover debt service costs if needed – regardless of the success of the water park.

While the water park project is projected to be operate with positive cash flow – three worst case scenarios were additionally presented: (1) no-alcohol sales; (2) break-even operations; and (3) water park is taken offline. Under the presented worst case scenarios rate adjustments will likely be required. Based on the presentation from Peiffer Brandt and Dan Martin (via phone) and receipt and consideration of each report, Council affirmatively decided to proceed with the financing.
