RESOLUTION

A RESOLUTION OF THE HARTSVILLE PLANNING COMMISSION TO RECOMMEND ADOPTION OF THE COMPREHENSIVE PLAN (VISION 2030) FOR THE CITY OF HARTSVILLE CONSISTENT WITH THE REQUIREMENTS OF THE SOUTH CAROLINA LOCAL GOVERNMENT COMPREHENSIVE PLANNING ENABLING ACT OF 1994.

WHEREAS, Title 6, Chapter 29 of the South Carolina Code of Laws, also known as the Local Government Compréhensive Planning Enabling Act of 1994 (the "Act"), establishes requirements and procedures for local governments with respect to the creation, adoption, and update of comprehensive plans (S.C. Code Ann. §6-29-310, et seq.); and,

WHEREAS, the Comprehensive Plan is intended to guide development in the City of Hartsville. It presents a vision for the future, with long-range goals and objectives for all land use decisions and regulations that affect the City of Hartsville; and,

WHEREAS, the Comprehensive Plan contains nine (9) elements: population, natural resources, cultural resources, community facilities, transportation, housing, land use, economic development, and priority investment as required by S.C. Code § 6-29-510(D) in addition to education; and,

WHEREAS, the Vision 2030: Progress and the Road Ahead, Public Involvement Summaries, City of Hartsville 2014 Master Plan, 2019 Retail Market Study and the 2019 Opportunity Zone Prospectus, serve as planning guides to achieve the policies, goals, objectives contained therein; are included in the Comprehensive Plan by reference (Appendices A through E) pursuant to S.C. Code §6-29-520(C) requiring review, consideration, and recommendation of other prepared plans and guides created through community involvement and input that meet the requirements of the South Carolina Local Government Comprehensive Planning Enabling Act; and,

WHEREAS, the Comprehensive Plan was developed through an extensive public participation process with a kick off meeting and biweekly and later monthly meetings through which all Hartsville residents and businesses were given the opportunity to provide input and participate in the development of the plan; and,

WHEREAS, in developing the Comprehensive Plan, the Planning Commission formed its recommendations for the physical development and finds that the plan represents the community's vision for future development and redevelopment of the City of Hartsville; and,

BE IT RESOLVED, that, the Hartsville Planning Commission, at its regular meeting, on Monday, October 26, 2020, pursuant to S.C. Code § 6 -29 520 (B) voted unanimously to recommend the Comprehensive Plan (Vision 2030) and referenced Appendices for adoption by City Council.
