UNFINISHED BUSINESS

PUBLIC HEARING AND FINAL READING ORDINANCE 4406: TO PROVIDE FOR THE ESTABLISHMENT OF A FIRE LINE TAP FEE AND FOR THE AMENDMENT OF THE MASTER FEE SCHEDULE – APPROVED.

NEW BUSINESS

RESOLUTION 12-12-01: TO ADOPT AND APPROVE A GENERAL FUND RESERVE POLICY – APPROVED. Mayor Pro-Tem asked for an explanation before the vote. City Manager Moore explained that the policy is recommended by our auditors and it memorializes what we should have available at any given time. This is just sound financial planning and management to have a 15-17% target for our fund balance.

Councilmember McGee thanked staff for their hard works putting this together and thanked Council for entertaining it.

Finance Director Caulder added that the public coffering statement for the bond rating wanted this put in place by the end of December for our "A" rating.

RESOLUTION 12-20-02: APPROVAL OF DESIGN BUILD CONTRACTOR FOR NEPTUNE ISLAND WATERPARK CONCESSION FACILITY – APPROVED.

Motion: McGee; Second: Caldwell; Discussion: City Manager Moore explained that this was done by RFQ so consideration was not just the bottom line. Comparing "apples to apples" Trident is better in tune to this type of contract. The difference will be \$50,000. The funds are already reserved for this project.

Waterpark Manager Braddock stated that Trident has provided excellent customer service and are very responsive to the needs of the park and have been involved with the park from the very beginning.

Finance Director Caulder stated that the other builder is not familiar with the park.

Councilmember McGee explained that he wanted to get the explanation on the record.

EMERGENCY ORDINANCE 4407: AN EMERGENCY ORDINANCE TO REAUTHORIZE THE REQUIREMENTS OF FACE COVERINGS IN CERTAIN CIRCUMSTANCES; TO REAUTHORIZE THE AUTHORIZATION FOR ELECTRONIC MEETINGS; AND OTHER MATTERS RELATED THERETO - APPROVED.

Motion: Caldwell; Second: McGee;

Discussion: City Manager explained that an Emergency Ordinance has a sunset clause of 60 days. Initial guidance was 180 days total not thinking COVID would last this long. Feel good extending beyond the 180 days total. Another option would be to pass a regular Ordinance with two readings to extend the requirement for face coverings and electronic meetings until the state of emergency has ended.

Councilmember Caldwell stated that he believes the city should follow information we have as we cannot please everyone and thanked the Council for passing the mask ordinance.
