The <u>2019</u> Statement of Economic Interests (SEI) report is <u>required</u> to be filed <u>electronically</u>. Paper copies of this report are <u>no longer accepted</u>. To file this report, please go to our website http://ethics.sc.gov. Electronic filing is <u>mandatory</u> and failure to file the required report electronically will result in a minimum <u>late filing penalty of \$100.00</u>. For new filers, please read the User's Guide found on our Home Page for (1) registering an account and (2) filing the 2019 Statement of Economic Interests report.

1. When is this report filed?

- A. The annual report is filed annually by March 30. Interims and new filers should register an account and file "upon assuming the duties."
- **B.** <u>Please note:</u> This annual report is not required if you are not holding an elected, appointed or employee position on March 30, 2019.
- C. <u>Please note:</u> Any person who is added due to promotion, new hire (including interims), change in staff organization, etc., is required to file the Statement of Economic Interests report immediately upon assuming the duties of the new position.
- **2. Where do you file this report online?** Go to our website http://ethics.sc.gov and click on "electronic filing."

If this is your first time filing, you must <u>first create a user account</u>. Go to our website http://ethics.sc.gov and click on "electronic filing." Read the information on that page carefully and click on "create a user account." After you create a username, create a password, and enter a valid e-mail address, then click "next." <u>There are several steps in creating a user account.</u> Read and follow the instructions carefully. Please click on "I am a candidate or elected official" if you are a candidate or elected. Click on "I only need to file a Statement of Economic Interests" if you are an appointed official or government employee.

After you create a user account you will receive this message: "You have successfully completed registration. Please <u>click here</u> to login to your account." You are now ready to start filing your first report.

Reset Password

You (the filer) must disclose (1) the source (name of Employer) and (2) the type (i.e., salary, rental income, vehicle, etc.) of any private income/benefit received in the previous year (2018) by you or a member of your immediate family (dependents) under the Income & Benefits section of the 2019 SEI. The dollar amount is required ONLY for government income. The dollar amount box will close when you click on "private."

The following income is not disclosed: retirement, annuity, pension, IRA, disability, or deferred compensation payments received by you. It also does not include income received from a court order, a savings, checking or brokerage account, and a mutual or

similar fund. State retirement, disability, social security, and private unemployment are not disclosed.

Report Instructions read: "Any full-time or part-time income or benefit received by you from governmental entities in South Carolina during the prior calendar year must be disclosed. Generally, this amount is the same as the gross amount reported on your W-2 form. If you receive a W-2 form or 1099 MISC for use of a publicly-owned vehicle or a government residence, then it must also be disclosed.





The Hartsville Police department employs 36 sworn positions, 3 civilians, and 8 crossing guards



Spring and Summer showed a marked increase in citations, however fall and winter are showing their usual slump. May showed our highest rates of ticket issuance for the previous 12 months. Hurricanes had a drastic impact on citations in September and October. Officers were involved with Hurricane preparation and flood mitigation, and wrote fewer tickets. Citations at this point are higher than last year, and we hope to see another rise towards spring.



March had a huge spike in arrests, due in large part to Operation Spring Freeze. April-June had shown a gradual drop towards average, with a large percentage of offenders being from outside the City limits. October had a marked decrease in arrests, however Arrests began returning to more of a normal level. Although November to December showed a slight decrease, there was not as much as an arrest slump as there was a citation slump. January had a huge rise in arrests.

Arrestees and Victims

On average, between 50-65% of arrested persons come from outside the city limits, showing that we serve many more people than our in-town population.

In January there were 212 arrests, including 8 Juveniles.

Crime Types

It is agreed that the premises shall be used as alleyway and no other use. Furthermore, the Lessor shall at all times keep the premises, improvements and appurtenances in a safe, clean and wholesome condition and comply in all respects with all laws, ordinances and regulations of every lawful authority having jurisdiction of premises.

ARTICLE 6 LESSEE TO CARRY LIABILITY INSURANCE

Lessee shall keep in effect at Lessee's expense during the term of this Lease: commercial liability insurance with a minimum limit of \$1,000,000 per occurrence.

ARTICLE 7 NOTICES

All notices required to be given to Lessor hereunder shall be sent by registered or certified mail and all rent payments shall be made to Lessor's agent at: Trust Company of South Carolina, PO Box 430, Hartsville, South Carolina 29551 or to such other address as Lessor may direct from time to time by written notice to Lessee by registered or certified mail.

All notices required to be given to Lessee hereunder shall be sent by registered or certified mail to Lessee at: 100 East Carolina Avenue, Hartsville, South Carolina 29550 or to such other address as Lessee may direct from time to time by written notice forwarded to Lessor by registered or certified mail.

ARTICLE 8 BINDING SUCCESSORS AND ASSIGNS

The covenants and agreements herein contained in the within Lease shall apply to, inure to the benefit of and be binding upon the parties hereto, their respective heirs, distributes, executors, administrators, legal representatives, successors and assigns.

ARTICLE 9 QUIET ENJOYMENT

The Lessee, upon payment of the rent and all sums herein reserved, and upon the due performance of all the terms, covenants, conditions and agreements herein contained on the Lessee's part to be kept and performed, shall and may at all times during the term hereby granted, including any extension hereof, peaceably and quietly enjoy the demised premises, subject, however, to the terms of this Lease.

ARTICLE 10 SIGNAGE

All signage must comply with all local codes and ordinances.

ARTICLE 11 ENTIRE AGREEMENT

It is understood and agreed that this agreement contains the entire agreement between the parties.

ORDINANCE 4359

AN ORDINANCE AUTHORIZING THE SALE OF TAX MAP PARCEL NUMBER 056-09-03-004 LOCATED AT 559 WEST CAROLINA AVENUE CONSISTING OF 1.81 ACRES (+/-).

BE IT ORDAINED by the Mayor and City Council of the City of Hartsville, South Carolina in council assembled that:

Section 1. Findings of Fact

The City Council of the City of Hartsville (the "City Council"), the governing body of the City of Hartsville, South Carolina (the "City"), has made the following findings of fact:

- (A) The City is a municipal corporation of the State of South Carolina (the "*State*") located in Darlington County, South Carolina, and as such possesses all general powers granted by the Constitution and statutes of the State of South Carolina to such public entities.
- (B) The Boykin Properties, LLC, a South Carolina limited liability company (the "*Developer*"), is investigating options and initiating preliminary diligence for the future development of the former armory building (the "*Project*") located at 559 West Carolina Avenue, Hartsville, South Carolina, identified as TMS No. 056-09-03-004 and more clearly depicted on Exhibit A hereto (the "*Property*").
- (C) The Property is currently vacant and has fallen into a state of disrepair. Absent the investment by the Developer through the implementation of the Project, the Property is an unlikely to be developed.
- (D) The City believes that the Project, if successful, will serve as a catalyst to further growth and development in the City as well as increased tourism, quality of life enhancement and community vitality. As such, the City seeks to offer incentives to the Developer to develop the Project.
- (E) Under the laws of the State, the City is authorized to sell, alien, convey, lease or otherwise dispose of real property.
- (F) The City has negotiated an option to purchase the Property with the Developer, the form of which is attached hereto as Exhibit B. (the "*Agreement*").
- (G) Certain terms of the Agreement provide for the Developer to purchase the Property for the sum of \$2.00, a cost that is substantially less than the fair market value of the Property. The City is cognizant that its authority to dispose of real property is limited by a fiduciary duty to act in the best interest of the public. The City has a fiduciary duty to receive consideration of "reasonably equivalent value" in exchange for its sale or conveyance of real property. In

determining what constitutes "reasonably equivalent value," a municipality is not limited to considering the monetary value received for the property but may also "consider indirect benefits resulting to the public in determining what is a fair and reasonable return for disposition of its properties..."

- (H) The City is mindful of and has considered the requirements of *Nichols v. South Carolina Research Authority*, 290 S.C. 415, 351 S.E.2d 155 (1986) and *WDW Properties v. City of Sumter*, 342 S.C. 6, 535 S.E.2d 631 (2000) (the "*Byrd Test*"), wherein public purpose of the proposed incentives is determined by the following four-part test: (1) what is the ultimate goal or benefit to the public intended by the project; (2) are public parties or private parties the primary beneficiaries; (3) is the benefit to the public speculative; and (4) what is the probability that public interest shall be served and to what degree.
 - (I) The City Council is enacting this Ordinance in order to:
 - (1) evidence the City's approval of the Project;
 - (2) authorize the sale of the Property to the Developer; and
 - (3) authorize the execution of and delivery by the City of the Agreement.

Section 2. Ratification of the Byrd Test; Recital of Indirect Benefits

- (A) The City reaffirms the criteria set forth by the South Carolina Supreme Court when it established the Byrd Test. The City, in negotiating the Agreement with the Developer as an incentive for the future development of the Project, complies with the objective provisions of the Byrd Test as described in Section 2(B).
 - (B) With regard to the Byrd Test recited above, the City believes that:
 - (1) the development of the Project is integral to the growth of the City and the Project shall serve as a catalyst for future development in the area;
 - (2) although some benefits inure to the Developer, the City is the primary beneficiary because the Project shall provide a direct economic impact to the City through increased tax levies, growth in property valuations, and the creation of jobs, and shall provide indirect economic impacts by attracting businesses, investment and patronage into the area and enhancing quality of life and enjoyment for City residents by developing blighted or vacant areas in the community, increasing property tax revenues within the areas surrounding the Project and increased demand in property and property values in the vicinity of the Project;
 - (3) while the development of the Project is speculative as the Developer is still performing its diligence and determining whether to make its investment, the terms of the Agreement provide for the City to increase the purchase price for the Property in the event

another interested purchaser makes an offer on the Property, thusly protecting the public's interest in the development of the Property; and

(4) the public interest shall be greatly served, as the Project is expected to generate investment within the City and create jobs. The direct investment of capital and the potential creation of jobs are beneficial to the success of the City and its general welfare.

Section 3. Authorization for Agreement

- A. The City Council has reviewed existing drafts of the Agreement and agrees that the inducements provided therein are beneficial to the City.
- B. The Agreement shall be executed and delivered on behalf of the City by the City Manager. Upon such execution, the City Council shall be timely informed of the execution of the Agreement and informed as to any material deviation of terms in the current draft. The consummation of the transactions and undertakings described in the Agreement, and such additional transactions and undertakings as may be determined by the City Manager, in consultation with legal counsel to be necessary or advisable in connection therewith, are hereby approved.

Section 4. Other Documents; Ratification of Prior Actions

In connection with the execution and delivery of the Agreement as well as all other deliverables authorized thereunder, the City Manager is additionally authorized to prepare, review, negotiate, execute, deliver, and agree to such additional agreements, certifications, documents, closing proofs, and undertakings as she shall deem necessary or advisable. Any actions previously undertaken by the City Manager, City Council or City staff in connection with the execution and delivery of the Agreement prior to the enactment of this Ordinance are ratified and confirmed.

Section 5. Severability

If any one or more of the provisions of this Ordinance should be contrary to law, then such provision shall be deemed severable from the remaining provisions, and shall in no way affect the validity of the other provisions of this Ordinance.

Section 6. Repealer

Nothing in this Ordinance shall be construed to affect any suit or proceeding impending in any court, or any rights acquired or liability incurred, or any cause of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

Section 7. Inconsistency

All ordinances, resolutions or parts of any ordinances or resolutions inconsistent or in conflict with the provisions of this Ordinance are hereby repealed to the extent of the conflict or inconsistency.

Section 8. Effect

This Ordinance shall be enacted upon final reading by the Hartsville City Council in meeting duly advertised and assembled the 12th day of February, 2019.

"Parties").				

WHEREAS, the City is the owner of that certain property (the "*Property*") described as follows:

Address: 559 West Carolina Avenue Hartsville, South Carolina

Tax Map No: 056-09-03-004

WHEREAS, the Developer is presently contemplating the purchase of the Property and desires to purchase an exclusive option to purchase the Property and the City desires to grant such an option; and

NOW THEREFORE, in consideration of the Option Price (as defined below) and other valuable consideration, the receipt and sufficiency of which as consideration are hereby acknowledged, the Parties hereby covenant, agree and contract as follows:

- 1. <u>OPTION TO PURCHASE; PURCHASE PRICE</u>. The City hereby bargains, grants, sells and conveys to the Developer an exclusive option to purchase the Property (the "*Option*") subject to the terms and conditions contained in this Agreement. During the Option Term (as defined herein) the Developer shall have the exclusive right to purchase the Property, subject to the provisions of this Agreement, for the purchase price of Two Dollars (\$2.00) (the "*Purchase Price*").
- 2. <u>CONSIDERATION FOR OPTION</u>. In consideration for the grant of the Option, in addition to the mutual covenants and promises contained in this Agreement, the Developer hereby agrees to pay the City the amount of One Dollar (\$1.00) (the "*Option Price*"). In the event that the Developer chooses to exercise the Option, the amount of the Option Price shall be applied to the Purchase Price. In the event that the Developer does not exercise the Option within the Option Term, the City shall retain the Option Price.
- 3. <u>TERM OF THE OPTION</u>. The Option term (the "*Option Term*") shall begin as of the Effective Date and shall automatically expire and terminate twenty-four (24) months later on ______, 2021 (the "*Expiration Date*"), unless extended by mutual agreement of the Parties.

4. <u>LIMITED EXCLUSIVITY</u>.

A. The City agrees, warrants and represents that the Option granted and conveyed pursuant to this Agreement is and shall remain the only option to purchase granted by the City for the Property during the Option Term, and that the City shall not take any action, or fail to take any necessary action,

that will result in the further encumbrance of the Property during the Option Term. However, the City may still actively pursue the sale of the Property to other interested investors, purchasers or developers.

- B. In the event a subsequent purchaser of the Property makes any offer to purchase the Property from the City, the City agrees to grant the Developer a right of first refusal allowing the Developer five (5) business days to beat any competing offer by a percentage of at least 5% (of the proffered purchase price) that is made during the pendency of the Option Term. In the event the Developer does exercise the right of first refusal, in writing and in accordance with the foregoing terms, the City, in its sole discretion, may elect to terminate the Option.
- 5. <u>EXERCISE OF OPTION</u>. The Option granted herein must be exercised by the Developer on or before the Expiration Date. The City acknowledges that the Developer may exercise the Option in its sole discretion and shall have no obligation to exercise the Option. In order to exercise the Option, the Developer shall deliver written notice (the "*Notice*") to the City by personal delivery or by certified mail. The Notice shall set forth the deadline for closing on the conveyance of the Property (the "*Closing Date*"), which shall not be less than 30 days, nor greater than 120 days, after the date upon which the Option is exercised. In the event that the Developer fails to exercise the Option within the Option Term, neither Party shall have any further liability or obligations under this Agreement.
- 6. <u>ACCESS TO PROPERTY; TESTS AND SURVEYS</u>. During the Option Term, the City shall permit the Developer's representatives to have full access to the Property for the purposes of conducting appraisals, surveys, soil and engineering studies, environmental surveys and other reasonable investigations (collectively, the "*Surveys*") of the suitability of the Property for the purposes contemplated by the Developer. The Developer shall bear the entire cost for any Surveys. In the event that any Survey requires the disturbance of the Property, the Developer shall restore the Property to its prior condition. The Developer shall provide the City with reasonable advance notice of any need to gain access to the Property, which shall not be less than 24-hours notice.
- 7. <u>COOPERATION</u>. The City agrees to cooperate fully with the Developer and its representatives, and to obtain the cooperation of anyone occupying the Property during the Option Term, in the Developer's efforts relating to the Surveys.
- 8. <u>CITY'S REPRESENTATIONS, WARRANTIES, AND COVENANTS</u>. The City hereby makes the following representations, warranties and covenants, each of which is limited to the knowledge of the City, without duty of the Developer to investigate the veracity thereof and each of which is material and is relied upon by Developer as consideration for the purchase of the Option, which are true and correct as of the Effective Date and which the City represents, warrants and covenants shall remain true and correct during the Option Term, and provided the Option is exercised by the Developer, through the Closing Date:
- A. The City is the sole owner of good and marketable fee simple title to all of the Property, insurable subject only to those liens, claims, options, encumbrances, rights-of-way, easements, conditions, covenants and restrictions as may be reasonably acceptable to the Developer.

- B. No options or other contracts have been granted or entered into which are still outstanding giving any other party a right to purchase any interest in the Property and no options or other contracts will be granted or entered into by the City giving any other party a right to purchase any interest in the Property.
- C. To the best of the City's knowledge, the City is not in violation of and, to the best of the City's knowledge, has not received notice of the violation of any applicable building, zoning or other ordinances, resolutions, statutes or regulations of any government or governmental agency in respect to operation, use, maintenance or condition of the Property or any part thereof or requiring any repairs or alterations.
- D. To the best of the City's knowledge, there are no condemnation or eminent domain proceedings pending or contemplated against the Property or to the best of the City's knowledge pending or contemplated against the Property or any part thereof, and the City has not received a notice, oral or written, of any public authority or other entity to take or use the Property or any part thereof.
- E. The City is current with all real and personal property taxes and the Property is free from special taxes or assessments. All roll back taxes accrued against the Property shall be paid by the City.
- F. The City has the right, power and authority to enter into this Agreement and to convey the Property in accordance with the terms and conditions of this Agreement. This Agreement, when executed and delivered by the City, will be a valid and binding obligation of the City in accordance with its terms.
- G. No payments for work, materials or improvements furnished to the Property will be due or owing upon the Closing Date, and the City shall execute standard mechanic's lien waiver forms as may be required by the Developer's title insurance company.
- H. The City has not, and has no knowledge or reason to believe that any other party has, stored or disposed of any substance or materials on the Property that would be classified by federal, South Carolina, or local laws or regulations as toxic or hazardous wastes or substances ("*Hazardous Substances*"), and the City has no knowledge or reason to believe that the Property contains any substances or material that would be classified by federal, South Carolina or local laws or regulations as Hazardous Substances
- I. The City shall not cause or permit any action to be taken, or fail to take such action when necessary, which would cause any of the foregoing representations or warranties to be untrue as of the Effective Date through the Expiration Date, or in the event that Developer elects to exercise the Option, the Closing Date. The City agrees to immediately notify the Developer in writing of any event or condition to the City's knowledge which occurs prior to the Expiration Date, or in the event the Developer elects to exercise the Option, the Closing Date, which causes a change in the facts related to or the truth of any of the above representations. The City has disclosed to the Developer, and will continue to disclose to the Developer, any and all facts necessary to prevent the statements herein from being misleading.

- J. On or before the Closing Date, the City will do, make, execute and deliver all such additional and further acts, deeds, instruments and documents as may be reasonably required by the Developer to completely vest in and assure to the Developer full rights in or to the Property.
- 9. <u>DEVELOPER'S WARRANTIES, REPRESENTATIONS, AND COVENANTS</u>. This Agreement, when executed and delivered by Developer, will be a valid and binding obligation of Developer in accordance with its terms. The undersigned representative of the Developer has the requisite power and authority to purchase the Option. In the event that the Developer elects to exercise the Option, the Developer will have taken such action necessary to authorize the purchase of the Property pursuant to the terms of this Agreement.
- 10. <u>RISK OF LOSS</u>. If the Property or any part thereof suffers any damage prior to the Expiration Date, or in the event that the Developer elects to exercise the Option, the Closing Date, from fire or other casualty, which the City shall have no obligation to repair, the City may either (a) terminate this Agreement and receive a refund of the Option Price, or (b) consummate the purchase of the Property, in which case, the proceeds of any insurance covering such damage, up to the amount of the Purchase Price, shall be assigned to the Developer on the Closing Date.
- 11. PRO-RATED ITEMS AND ADJUSTMENTS. The City shall pay for the cost of all deed stamps and transfer taxes and the Developer shall pay for the recording fees of this transaction. The Parties shall each pay their own legal fees related to the transaction contemplated hereby. The City shall be responsible for payment of all expenses applicable to the Property which are incurred prior to the Closing Date. The Developer shall be responsible for payment of all expenses applicable to the Property which are incurred from and after the Closing Date including, but not limited to, real estate taxes and assessments and fire, hazard, theft and liability insurance premiums. The adjustments and prorations required under this Agreement shall be computed as of the Closing Date and the Purchase Price paid to the City hereunder shall be adjusted to reflect such prorations. The City shall be responsible for any rollback taxes relating to the Property, which amounts shall be estimated and deducted from the proceeds paid to the City. The City shall be responsible for paying to the City any shortfall due on rollback taxes immediately upon receipt by the City of the actual tax or rollback tax bill.
- 12. <u>DELIVERY OF CLOSING DOCUMENTS</u>. In addition to other conditions precedent set forth elsewhere in this Agreement, the City shall deliver to the Developer on the Closing Date all of the following documents, the delivery and accuracy of which shall further condition the Developer's obligations to consummate the purchase and sale herein contemplated:
- A. A Limited Warranty Deed satisfactory in form and substance to counsel for the Developer, conveying good and marketable fee simple title to the Property, free and clear of all liens, encumbrances, easements and restrictions of every nature and description, except those previously approved in writing by the Developer.
- B. The City's affidavit or lien waiver satisfactory for the purpose of removing any mechanic's lien exception from any title insurance policy to be issued in connection with the purchase of the Property.

- C. An affidavit of the City providing the City's federal identification number and certifying that this transaction is not subject to withholding taxes in accordance with the laws of the State.
- D. Evidence the authority of the persons signing the deed and other documents to be executed by the City at closing and the power and authority of the City to convey the Property to the Developer in accordance with this Agreement.
- E. Such other documentation as may be reasonably required in the opinion of the Developer or its counsel to consummate and close the transaction contemplated herein pursuant to the terms and conditions of this Agreement.
- 13. <u>POSSESSION</u>. Possession of the Property shall be delivered to the Developer at the time of closing and delivery of the limited warranty deed.
- 14. <u>COMPLETENESS AND MODIFICATION</u>. This Agreement constitutes the entire agreement between the Parties hereto with respect to the transactions contemplated herein and it supersedes all prior discussions, undertakings or agreements between the Parties. This Agreement shall not be modified except by a written agreement executed by the Parties.
- 15. <u>BINDING EFFECT</u>. This Agreement shall be binding upon and inure to the benefit of the Parties hereto, and their respective successors and assigns.
- 16. <u>COUNTERPARTS</u>. To facilitate execution, this Agreement may be executed in as many counterparts as may be required.
- 17. <u>INVALID PROVISIONS</u>. In the event any one or more of the provisions contained in this Agreement shall be for any reason held invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provision of this Agreement; this Agreement shall be construed as if such invalid, illegal or unenforceable provision had never been contained herein or therein.
 - 18. TIME. Time is of the essence of this Agreement and the provisions hereof.
- 19. <u>RECORDING</u>. Either Party may record a memorandum of this Agreement in the Office of the Register of Deeds for Darlington County.

This agreement is made and entered into this ______ day of January, 2019, by and between the **CHESTERFIELD COUNTY SHERIFF'S OFFICE**, 203 Watson Street, Chesterfield, SC 29709 and the **HARTSVILLE POLICE DEPARTMENT**, 135 W. Carolina Avenue, Hartsville, SC 29550.

WHEREAS, as amended on June 3, 2016, South Carolina Code Ann. Section 23-20-10, et seq., provides for contractual agreements between and among state, county, municipal and local law enforcement agencies for the purpose of providing the proper and prudent exercise of public safety functions across jurisdictional lines;

WHEREAS, the CHESTERFIELD COUNTY SHERIFF'S OFFICE desires to enter into such an agreement with the HARTSVILLE POLICE DEPARTMENT for the purposes of securing to each other the benefits of mutual aid in the event of natural disaster, disorder, special events, emergency situations, and any other law enforcement activities;

WHEREAS, the purpose of this Agreement is to define the scope of such mutual aid and the responsibilities of the parties; and

WHEREAS, during these activities, it is possible that law enforcement officers will respond to, become involved with, and/or deal with emergency situations, civil disorders, arrests, natural or manmade disasters, pursuits of criminal suspects, location of missing persons, criminal investigations, and/or any other matter handled by law enforcement, and the requesting agency desires replying agency's officers to have lawful authority and jurisdiction to respond to, become involved with, and/or deal with these or any other situations which may arise during the presence of responding agency's officers in the requesting agency's jurisdiction.

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, it is the intent of the parties to share jurisdiction under this written Agreement to the fullest extent permitted under South Carolina law and it is further agreed as follows:

1. VESTING OF AUTHORITY AND JURISDICTION

To the fullest extent permitted by the Constitution and the statutes of this State, officers assigned under the Agreement shall be vested with authority, jurisdiction, rights, immunities, and privileges outside his resident jurisdiction for the purpose of investigation, arrest, or any other activity related to the criminal activity for which the agreement is drawn. This Agreement is in no way intended to effect any other multi-jurisdictional agreement(s) which may exist between the agencies. The assistance to be rendered pursuant to this Agreement shall solely involve responding law enforcement officers from one party's jurisdiction to the other. When so responding, such law enforcement officers shall have all powers and authorities of law enforcement officers employed by the requesting jurisdiction. However, local ordinances adopted by a responding party's jurisdiction shall not be deemed

extended into areas of operation that are located outside the geopolitical territorial limits of that party.

2. REQUEST FOR ASSISTANCE

The responding law enforcement officers may be requested in response to any public safety function across jurisdictional lines, such as multijurisdictional task forces, criminal investigations, patrol services, crowd control, traffic control and safety, and other emergency service situations. Assistance provided in this Agreement includes, but is not limited to:

- A. Emergency Situations;
- B. Civil Disorders;
- C. Natural or Manmade Disasters;
- D. Mass Processing of Arrests;
- E. Transporting of Prisoners;
- F. Operating Temporary Detention Facilities & Housing Inmates;
- G. Arrests;
- H. Pursuits of Criminal Suspects;
- I. Location of Missing Persons;
- J. Traffic Control and Safety;
- K. Criminal Investigations; or
- L. Any Other Matter Handled by Law Enforcement for that Particular Jurisdiction.

3. PRIMARY RESPONSIBILITY

It is agreed and understood that the primary responsibility of the parties to this Agreement is to provide law enforcement services within the geographical boundaries of their respective jurisdictions. Therefore, it is agreed that the law enforcement agency whose assistance is requested shall be the sole judge as to whether or not it can respond and to what extent it can comply with the request for assistance from the other agency.

4. PROCEDURE FOR REQUESTING LAW ENFORCEMENT ASSISTANCE

- A. Request. A request for assistance shall only be made by the Sheriff of Chesterfield County, or his/her designee, or the, Chief of Hartsville Police Department or his/her designee. This request shall include a description of the situation creating the need for assistance, the specific aid needed, the approximate number of law enforcement officers requested, the location to which law enforcement personnel are to be dispatched, and the officer in charge of such location.
- B. Reply. A reply to any request for assistance shall only be made by the Sheriff of Chesterfield County, or his/her designee, or Chief of Hartsville Police Department, or his/her designee. If the request is granted, the requesting law enforcement agency shall be immediately informed of the number of law enforcement officers to respond.

- C. Officer in Charge. The responding law enforcement officers shall report to the officer in charge of the requesting law enforcement agency at the designated location and shall be subject to the lawful orders and commands of that officer. The responding law enforcement officer shall exert their best efforts to cooperate with, and aid, the requesting law enforcement agency. The responding law enforcement officers shall be responsible at all times for acting within the policies and procedures set forth in the policy and procedure manual of the law enforcement agency by which they are regularly employed.
- D. <u>Release.</u> The responding law enforcement officers shall be released by the officer in charge when their services are no longer required or when they are needed to respond to a situation within the geographic boundaries of their own jurisdiction; provided however, the responding law enforcement officers shall use their best efforts to complete the requested service prior to being released.

5. PERSONNEL, COSTS AND RECORDS

Except as otherwise agreed among the parties, each party shall maintain control over its personnel. Except as otherwise provided herein, each party shall bear its own costs incurred in the performance of its obligations hereunder, and shall keep its own personnel and other usual records as to its assigned officers.

Any and all records of law enforcement activities conducted pursuant to this Agreement shall be the property of and maintained by the agency conducting the activity, including any incident reports, citations, photographs, or other images captured on any photographic or digital media. Nothing contained herein prohibits or precludes any participating agency from making or maintaining a copy of any such records referenced above.

6. REQUESTS FOR INFORMATION PURSUANT TO THE SOUTH CAROLINA FREEDOM OF INFORMATION ACT

Upon receipt, each agency participating in this Agreement must respond to requests for information pursuant to the South Carolina Freedom of Information Act.

7. COMPENSATION

This Agreement shall in no manner affect or reduce the compensation, pension, or retirement rights of any responding officer. Except as otherwise agreed, each party shall bear its own costs and expenses incurred in complying with this Agreement.

8. INSURANCE

Each party shall maintain such insurance coverage for general liability, workers' compensation, and other such coverage as may be required by law or deemed advisable by individual parties.

9. EMPLOYMENT STATUS

Nothing herein shall be construed or interpreted to imply that the law enforcement officers responding in accordance with this Agreement shall be the employees of the law enforcement agency requesting such assistance.

10. MODIFICATION OR AMENDMENT

This Agreement shall not be modified, amended, or changed in any manner except upon express written consent of the parties to this Agreement.

11. RESPONSIBILITY TO RESPECTIVE GOVERNING BODIES

Each party is responsible for any approval requirements to their respective governing body as may be required under South Carolina law.

12. SEVERABILITY

Should any part of this Agreement be found to be unenforceable by any court or other competent authority, then the rest shall remain in full force and effect.

13. BINDING SUCCESSORS IN OFFICE

All parties agree that any and all successors in interest to their offices will be similarly bound by the terms of this agreement without necessitating execution of any amendment.

14. NO INDEMNIFICATION OR THIRD PARTY RIGHTS

To the extent provided by law, the parties shall be solely responsible for the acts and omissions of their respective employees, officers, and officials, and for any claims, lawsuits and payment of damages that arise from activities of its officers. No right of indemnification is created by this agreement and the parties expressly disclaim such. The provisions of this agreement shall not be deemed to give rise to or vest any rights or obligations in favor of any rights or obligations in favor of any party or entity not a party to this agreement.

15. TERMINATION

This Agreement shall be terminated at any time upon written notice to the other party to this Agreement.

16. TERM AND RENEWAL

This Agreement is effective as to each party at the date and time of signing and will automatically renew each anniversary date, year to year, and term to term unless a party exercises its right to terminate as further described herein.

17. USE OF EQUIPMENT AND FACILITIES

Each party shall be responsible for the maintenance of its own equipment and shall be responsible for the procurement of facilities unless otherwise agreed upon by the parties.

ORDINANCE 4360

AUTHORIZING AND RATIFYING THE CONVEYANCE AND TRANSFER OF CERTAIN REAL PROPERTY; AND OTHER MATTERS RELATING THERETO.

BE IT ORDAINED by the Mayor and City Council of the City of Hartsville in a meeting duly assembled:

Section 1. Findings of Fact

The City Council of the City of Hartsville (the "*City Council*"), the governing body of the City of Hartsville, South Carolina (the "*City*"), has made the following findings of fact:

- (A) The City is a municipal corporation of the State of South Carolina (the "*State*") located in Darlington County, South Carolina, and as such possesses all general powers granted by the Constitution and statutes of the State of South Carolina to such public entities.
- (B) The Hartsville Public Development Corporation (the "*Corporation*") is a South Carolina nonprofit corporation, incorporated, organized and existing under the laws of the State of South Carolina.
- (C) The Corporation has been formed to assist in the development of public facilities and other projects which benefit the City.
- (D) The Corporation is controlled by City Council as two of its three directors are appointed by City Council.
- (E) The City has previously acquired certain properties as listed on <u>Exhibit A</u> attached hereto (the "*Parcels*"), all of which will be or have been acquired by the Corporation.
- (F) The Corporation, acting in concert with the City, has stated its intent to develop or arrange for the development of a mixed-use commercial and residential development, currently known as the "Canalside Project", which is intended to benefit the City by further developing and improving its downtown corridor and adding multi-family housing options and commercial development, which are needed in the City ("**Project**").
- (G) The City believes that the development of the Project will serve as a catalyst to further interest, investment and development of Canalside as well as increased tourism, quality of life enhancement and community vitality. As such, the City seeks to incentive the Project as it deems appropriate.
- (H) By the terms of its Articles of Incorporation and its Bylaws, the Corporation is authorized "to acquire, by gift, lease or purchase…any property, real or tangible personal, incidental to carrying out" projects located in and for the benefit of the City.

- (I) The City is authorized by the laws of the State to sell, alien, convey, lease or otherwise dispose of real property.
- (J) The City, under the terms of Ordinance 4325 dated March 13, 2018 ("*Ordinance* 4325"), has previously authorized the transfer of City Parcels and Other Parcels (as each such term is defined in Ordinance 4325). The City Parcels and the Other Parcels were determined by the City Council to benefit the Project.
- (K) By the terms of this Ordinance and similar to the provisions of Ordinance 4325, the City intends to convey the Parcels to the Corporation; alternatively, to the extent any of the Parcels have already been conveyed to the Corporation, the City intends to ratify such conveyance. In making such conveyances, the City is cognizant that its authority to dispose of real property is limited by a fiduciary duty to act in the best interest of the public. The City has a fiduciary duty to receive consideration of "reasonably equivalent value" in exchange for its sale or conveyance of real property. In determining what constitutes "reasonably equivalent value," a municipality is not limited to considering the monetary value received for the property but may also "consider indirect benefits resulting to the public in determining what is a fair and reasonable return for disposition of its properties...."
- (L) The City is mindful of and has considered the requirements of *Nichols v. South Carolina Research Authority*, 290 S.C. 415, 351 S.E.2d 155 (1986) and *WDW Properties v. City of Sumter*, 342 S.C. 6, 535 S.E.2d 631 (2000) (the "*Byrd Test*"), wherein public purpose of the proposed incentives is determined by the following four-part test: (1) what is the ultimate goal or benefit to the public intended by the project; (2) are public parties or private parties the primary beneficiaries; (3) is the benefit to the public speculative; and (4) what is the probability that public interest shall be served and to what degree.
 - (M) The City Council is enacting this Ordinance in order to:
 - (1) authorize the conveyance of the Parcels by grant (or a substantially below-market sale) to the Corporation;
 - (2) ratify and approve of the conveyance of any of the Parcels by grant (or a substantially below-market sale) to the Corporation which may have occurred prior to the enactment of this Ordinance;
 - (3) to confirm its support for the Project; and
 - (4) authorize the execution and delivery by, and on behalf of, the City of such other agreements and certificates and the taking of such other action by the City (acting through the City Manager) as shall be necessary or desirable in connection with the conveyance of the Parcels.

Section 2. Ratification of the Byrd Test; Recital of Indirect Benefits

- (A) The City reaffirms the criteria set forth by the South Carolina Supreme Court when it established the Byrd Test. The City, in conveying the Parcels to the Corporation, understands and affirms that the Corporation plans to use the Parcels, as well as the City Parcels and the Other Parcels, as an incentive for the development of the Project; for these reasons, of the City's conveyance of the Parcels complies with the objective provisions of Byrd Test as described in Section 2(B).
 - (B) With regard to the Byrd Test recited above, the City believes that:
 - (1) the development of the Project is integral to City's redevelopment efforts and the Project shall serve as a catalyst for future redevelopment in the area; further, there is a significant amount of excitement and anticipation throughout the City in support of the Project;
 - (2) although some benefits inure to the Corporation, the City is the primary beneficiary because the Project shall provide a direct economic impact to the City through increased taxes, growth in property valuations, and the creation of jobs, and shall provide indirect economic impacts by attracting businesses, investment and patronage into the area and enhancing quality of life and enjoyment for City residents by developing blighted or vacant areas in the community, increasing property tax revenues within the areas surrounding the Project and increased demand in property and property values in the vicinity of the Project;
 - (3) while the Project is still in its introductory phase, the Corporation's state corporate purpose is to serve the City's best-interests and through the City Council's control of the Corporation it can ensure that the Project is developed in a manner best benefitting the City; and
 - (4) the public interest shall be greatly served, as the Project is expected to generate investment within the City and potentially create jobs. The direct investment of capital and the potential creation of jobs are beneficial to the success of the City and its general welfare.

Section 3. Authorization to Convey Property

- A. In order to incentivize and induce the success of the Project, the City may convey the Parcels by grant, sale or otherwise to the Corporation; in the event of a sale, the amount of the sale may be for amounts less than the appraised value of any the Parcel and the specific sales price may be determined by the City Manager based on her estimate of best value at the time of conveyance.
- B. To the extent any of the Parcels have already been transferred or conveyed by the City to the Corporation, such transfers or conveyances, whether they were processed by grant, sale

or otherwise, are ratified, approved and confirmed.

C. The consummation of the transactions and undertakings described in this Ordinance, and such additional transactions and undertakings as may be determined by the City Manager, in consultation with legal counsel to be necessary or advisable in connection therewith, are hereby approved.

Section 4. Other Documents; Ratification of Prior Actions

In connection with the execution and delivery of the conveyance documents, the City Manager is additionally authorized to prepare, review, negotiate, execute, deliver, and agree to such additional agreements, certifications, documents, closing proofs, and undertakings as she shall deem necessary or advisable. Any actions previously undertaken by the City Manager, City Council or City staff in connection with the conveyance of the Parcels prior to the enactment of this Ordinance are ratified and confirmed.

Section 5. Severability

If any one or more of the provisions of this Ordinance should be contrary to law, then such provision shall be deemed severable from the remaining provisions, and shall in no way affect the validity of the other provisions of this Ordinance.

Section 6. Repealer

Nothing in this Ordinance shall be construed to affect any suit or proceeding impending in any court, or any rights acquired or liability incurred, or any cause of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

Section 7. Inconsistency

All ordinances, resolutions or parts of any ordinances or resolutions inconsistent or in conflict with the provisions of this Ordinance are hereby repealed to the extent of the conflict or inconsistency.

Section 8. Effect

This Ordinance shall be enacted upon final reading by the City Council.




Recent Sales By Distance
