### Call to Order/Minutes

Chairman Lee then introduced Shannon Munoz the new Director of Community and Economic Development.

### **New Business**

### Coker College – Historic Designation – 217 & 219 E. Carolina Ave.

Brenda Kelley provided a summary of Coker College's request for historic designation for 217 & 219 East Carolina Avenue. During its May 2018 meeting the Architectural Review Board made a recommendation to City Council to approve the designation. The ordinance requires the Planning Commission to comment prior to City Council's recommendation. The commissioners supported ARB's recommendation.

### **Microbrewery Ordinance**

Brenda Kelley presented a draft ordinance. The commissioners discussed hours of operation, overall square footage and the square footage of various portions of a brewery, the proximity to residentially zoned properties, etc. The board wanted the ordinance to provide a degree of flexibility for owners. After much discussion and consideration, Mark Stellingworth made a motion to table the ordinance for additional information.

### **Comprehensive Plan**

Chairman Lee talked about the public meeting scheduled for June 2018. The meeting would inform the public updated information about the process of the plan. The public would also be given an opportunity to provide input. Chairman Lee talked about policy, projects, and programs and high level goals. He also mentioned the big projects such as the Water Park and the Canal District.
