## **PRESENTATIONS**

Proclamations - Mayor Pennington presented:

- a. American Legion Centennial –Post 53 is celebrating 100 years of supporting veterans, children, youth, American Legion Baseball, boys to boys state and other activities. The 100-year flag will be flown over city hall on Friday June 14, 2019.
- b. Coker University Dr. Robert Wyatt accepted the proclamation on behalf of Coker University. The official name change will occur on July 1, 2019 and the Mayor proclaimed July 1, 2019 as Coker University Day.
- c. Men's Health Month Became a public law 103-264 in May of 1994 and this proclamation for June as Men's Heath Month will be entered into the congressional record.

Lady Red Foxes - State Softball Champions – Councilmember Braddock introduced the Lady Red Fox Softball Championship Team along with their coach, Tommy Garrison. The Lady Foxes had a 29-0 season.

Free Medical Clinic - Stephen Edwards, Executive Director – introduced himself as a Darlington native and explained that DHEC statistics show that in 2018 the adult population in Darlington County is 15.6% uninsured, 42% are obese, 7.5% have an increase stroke rate. The Free Medical Clinic will be

holding free mammogram clinics and will assist citizens that qualify with SC Voc Rehab, SC Works, PDRTA, and Darlington Lions Club for vision, CPRMC for diagnostic testing at reduced rates. Within 60 days a full-time medical provider will be rotating between the two locations.

Sewer Fees - Larry Gantt – Mr. Gantt requested City Council provide a sewer fee modification for residents that are not connected to sewer service, but are required by low to pay for the service. Mayor asked staff to review and report to Council and get back with Mr. Gantt.
