#### Call to Order/Welcome

#### **Approval of Minutes**

Motion made by Wingfield to approve the September 16, 2020 minutes as submitted; Second: Rogers; Carried: All in favor.

#### **Applications**

#### Peace of Heaven – 120 E. Carolina Ave. – window and signs, paint

Jim and Frances Taggart were present to participate in the discussion regarding the application. Mrs. Taggart presented the request for a 15 square foot window sign, a four (4) square foot window sign and a two (2) square foot sign on the rear door. The three (3) signs would read, Peace of Heaven" with the logo. The signs would be made of white vinyl lettering. The logo would have a gold background with a white dove in vinyl. The request also included painting the wooden box and a small piece of stucco on the front of the building. Both would be painted a Sherwin Williams (SW 7512) Pavilion Beige. Gandy made a motion to approve the application as submitted; Second: Rogers. Carried: All in favor.

### Sea Mist Fresh Seafood Company – 130 S.S Sixth St. – window and projecting signs

Roger Gore was present to participate in the discussion regarding the application. Mr. Gore presented the request for an 8.8 square foot sign on each window on the front elevation. Each sign would include the business name and logo with a wave at the bottom of each window. The signs would be made of vinyl. A 10 square foot projecting sign would be installed on an existing metal bracket on the upper portion of the front elevation, centered above the door. The non-illuminated sign would be made of a 6mm solid core aluminum. Wingfield made a motion to approve the application as submitted; Second: Rogers. Carried: All in favor.
