Call to Order/Welcome

Chairman Nancy McGee called the meeting to order at 5:30pm.

Approval of Minutes

Lee made a motion to approve the October 26, 2020 minutes as submitted; Second Shirley. Carried: All in favor.

New Business

Approval of the 2021 Planning Commission Calendar

Chairman McGee recommended two (2) changes to the Calendar. The meeting scheduled on the Memorial Day Holiday on May 31 would change to Monday, May 17. The meeting scheduled on one of the Christmas Holidays on December 27 would change to Monday, December 20. Lee made a motion to approve the 2021 Calendar with the two (2) changes; Second McDonald. Carried: All in favor.

Canal District Update

Ex-Officio Daniel Moore presented a preliminary draft on the Canal District Code. The canal district would be made up of 11 acres and seven districts. 200 -300 residential units and 67,000 square feet of commercial space are proposed. The units would be 2 -4 stories depending on need. A water feature would be in the middle and canal would run through certain areas. The zoning for the district would include a form based code and a regular code creating a Planned Unit Development. The canal district would be a highly dense expansion of downtown. The Canal District is a part of the multi-county business park.

Moore than defined the Planning Commission role.

- Authority to do Planned Unit Developments.
- The Planning Commission would focus on the setbacks.
- Create, review and recommend to Council a Planned Unit Development
- Reviewing and making sure codes meet the City's requirements.

Planning Commissioners were given an opportunity to provide comments. Hancock provided an update on the brewery. Lee commented that the terminal at the airport is under construction.
