Re: Request for Board Expansion

Gentlemen:

The Board of Directors of Hartsville Public Development Corporation (the "Board"), as the governing body of the Hartsville Public Development Corporation (the "Corporation"), met on Tuesday, February 2, 2021, to discuss potential amendments to the Corporation's bylaws, as adopted on January 10, 2018 and approved by the Board on January 11, 2018 (the "Bylaws"). Particularly, and in light of the ongoing development opportunities associated with the Canalside development, which both the City of Hartsville (the "City") and the Byerly Foundation ("Byerly") have strongly supported, and the need to add additional skill sets to the Board, the Board determined that the need exists to expand the composition of the Board to expand it from three directors (currently) to five directors (as proposed).

As you may recall, of the 3 current directors on the Board, 2 directors are appointed by the City and 1 director is appointed by Byerly. The Board proposes to increase its composition by adding 1 additional appointed director – appointed by the City, and 1 additional director to be elected by the appointed directors on the Board. Proposed language to accomplish this proposed amendment is attached to this letter for your review and consideration.

While the Board is authorized to amend the Bylaws by a unanimous vote of the directors then in office, changes to the composition of the Board additionally require the approval of the City and Byerly. As a result, this letter represents the Board's formal request to each of the City and Byerly for approval to expand the composition of the Board and thereafter make certain conforming changes to the Bylaws as proposed in the attachment hereto.

Assuming each of your organizations is agreeable to the foregoing request, please have your respective governing bodies approve this request and thereafter, please execute a counterpart of the attached Acknowledgment and Approval and return an executed copy to my attention.
