- 2. The American Rescue Plan document is before you. We know that the funds are not ready for us at the state level. Non-entitlement cities are in a waiting game. Hopefully, the legislature will take this up in September. The rules have changed and grant matches are no longer allowed. The city can apply for loss revenue, infrastructure, and premium pay for front-line workers. At this time, we are scheduled to receive \$3.75 million, when we get it. We have two water tanks in need of work now. A CIP list will be sent out via email to Council.
