#### MASHR, LLC dba Wild Heart Brewing Company – 317 Railroad Ave. – canopy

Casey Hancock and Tony Tornovish were present to participate in the discussion regarding an application to install an aluminum-framed structure over a portion of the deck. The structure would have clear corrugated plastic roofing panels in an effort to protect a larger part of the deck from the rain while still allowing sunlight to light the space. Mr. Tornovish presented a sample of the canopy. Rogers made a motion to approve the canopy as submitted; Second: Tuten. Carried: All in favor.

# Hartsville Armory – 559 W. Carolina Ave. – Bailey Bill Application, Preliminary Certification & Certificate of Appropriateness

Justin Evans and Janie Campbell, Preservation Consultant with Rogers, Lewis, Jackson, Mann & Quinn, LLC and were present to participate in the discussion regarding a Bailey Bill Application, Preliminary Certification and Certificate of Appropriateness for the Hartsville Armory at 559 West Carolina Avenue. They also presented a Historic Preservation Certification Application that was submitted to the National Park Service. The building is listed on the National Register. The estimated project cost \$3,000,000.00 exceeds 20% of the \$90,500.00 fair market value of the property. Ms. Campbell and Mr. Evans spoke about the types of improvements that would be made as a part of the project. An addition would be made to the building as well. Tuten made a motion to approve the Bailey Bill Application and the Preliminary Certification as submitted, the Certificate of Appropriateness is approved contingent upon receipt of the sight plan; Second: Goodson; Carried: All in favor.
