Proclamation was presented to the Hartsville Fire Department for National Fallen Firefighters Day and Fire Prevention Month. Chief Burr expressed gratitude for this recognition especially this year with the 20th anniversary of September 11, 2001 still very much on our minds. He also reminded everyone to never forget.

Monthly Department Report: Jeff Burr, Fire Chief: He informed everyone that the Hartsville Fire Department was formed in 1903 and now today they service around 29,000 within the city and the five miles around the city with equipment and manpower. Through their mission and function they perform life safety, instant stabilization, and property conservation.

Approval of First Reading and Waiving of Complete Reading: Motion: Braddock; Second: McGee; Carried: with all ayes.

RESOLUTION 09-21-01: APPOINTMENT TO HOUSING AUTHORITY OF HARTSVILLE BOARD – APPROVED.

Motion: Mack; Second: Braddock to appoint Crandell Lighty; Carried: All ayes.

RESOLUTION 09-21-02: TO PROVIDE FOR THE AMENDMENT OF FEES THAT ARE NECESSARY FOR THE OPERATION OF THE CITY OF HARTSVILLE – APPROVED.

Motion: McGee; Second: DeLaine; Discussion: City Manager Moore explained this was to update rental and operational fees; some fees will go down. Carried: All ayes.

RESOLUTION 09-21-03: APPROVAL TO AUTHORIZE EXPENDITURE OF A PORTION OF THE AMERICAN RESCUE PLAN ACT FUNDS BY THE CITY OF HARTSVILLE – APPROVED.

Motion: Braddock; Second: Caldwell; Discussion: City Manager Moore explained that after a lengthy discussion with the Mayor he desires to increase from option 3 to 4. We never lost any service to anyone during COVID, this is in recognition of that. To invest in our staff is money well spent. The rate is derived from hours worked during COVID. Motion to amend to select option 4 changing the amount to up to \$410,000: Andrews; Second: Mack. Carried as amended with all ayes, with the exception of McGee voting nay.

FIRST READING ORDINANCE 4422: AN ORDINANCE TO AMEND BY REPEALING AND REPLACING CHAPTER 14 "BUSINESS LICENSE" ARTICLE II "BUSINESS LICENSE PROGRAM" OF THE CITY'S CODE OF ORDINANCE IN ACCORDANCE WITH THE BUSINESS LICENSE BILL (H4431) PASSED BY THE SOUTH CAROLINA LEGISLATURE IN SEPTEMBER 2020 - APPROVED.

Approval of First Reading and Waiving of Complete Reading: Motion: DeLaine; Second: Mack; Discussion: This will change the business licenses rates by .01% and smaller businesses are the winners. By state law this ordinance must be adopted by January 2022. Carried: with all ayes.
