#### Hi-Style Salon – 127 W. Carolina Ave. – wall-mounted, window and door signs, paint

Megan Young was present to participate in the discussion regarding an application for a wall-mounted, window and door sign. She also proposed painting the building. The name of the business will change to Hair On Carolina. The wall-mounted sign would be a 16 square foot circular sign. The window sign would be a four (4) square foot circular sign. The door sign would be less than one (1) square foot. All signage would have a white background with gold letters. The building would be painted in a shade of Olive, SW 6215 Rocky River. Tuten made a motion to approve the application as submitted; Second: Wingfield. Carried: All in favor.

## Purrs McBarkin' LLC - 126 E. Carolina Ave. - wall-mounted, window and awning signs

David Zanoni was present to participate in the discussion regarding an application for two (2) 3.125 square feet window signs, a 15 square foot awning sign and an 18 square foot wall-mounted sign on the rear. The window signs would have a white background with a black and white logo and black letters. The awning sign would have a brown background to blend with the existing awning and white letters. The rear sign would also have a white background with a black and white logo and black letters. Mr. Goodson said the backing for the awning sign could contrast. It does not have to match. Tuten made a motion to approve the window signs and the awning sign as submitted, the rear sign shall not exceed 12 square feet; Second: Wingfield; Carried: All in favor.

# The Station – 114 South Fourth St. – projecting sign

Brandy Stellingworth was present to participate in the discussion regarding an application to erect an eight (8) square foot, double sided sign on an existing metal post and arm. The sign would be made of

wood and steel. Tuten made a motion to approve the projecting sign as submitted; Second: Goodson; Carried: All in favor.
