Discussion: City Manager Moore explained this is a step to transition from yard debris being placed on curbs to having it placed in bags in an effort to keep yard debris out of the storm drains, allow crews to operate more efficiently, and help with the erosion on curbs. The public will receive communication in advance of this becoming effective January 1, 2023.
