Mayor Pro-Tem Andrews called the meeting to order at 5:32pm and asked Councilmember Mack to lead in the invocation and Pledge of Allegiance.

## **PRESENTATIONS**

<u>Proclamation</u> – Mayor Pro Tem Andrews presented a proclamation declaring December 2, 2022 as Arbor Day to Public Services Director Bethea. Hartsville has been a Tree City for decades.

## **Public Comments**

Grady Weaver, 551 Lakeshore Drive, thanked Council and staff for assistance on McLeod Road.

Sheila Mullis, 613 West College Avenue: expressed concerns related to trees planted in right-of-way causing safety issues due to leaves in storm water drains and roots pushing up areas in sidewalks. Asked City's responsibilities in relation to trees in the right-of-way, benefits of change to yard debris process and penalties for non-compliance. Asked Council to please reconsider changes to yard debris program.

Alan Norwood, 619 West College Avenue: questioned what the change to yard debris program accomplishes and would like to see actual numbers on savings. Requested removal of a tree in the right-of-way of his property. Suggested reducing the amount of yard debris tonnage removed by City through tougher enforcement of penalties on non-compliant lawn care contractors who are not hauling off debris.

Tony Tornovish, 809 West Home Avenue: questioned if change for yard debris program resulted in any cost savings as costs are still incurred to pick up bags and brown rollcarts. Loves Hartsville and feels the change negatively impacts quality of life in Hartsville.

Drew Hamilton, 305 Dahoon Lane: lives in a neighborhood with many trees. Several years ago, Clemson recommended not mulching leaves but bagging them. During a recent trip to his hometown, he noticed yards looked as if owners didn't care how bad they looked. This change makes it more difficult to deal with leaves and yards will look like uncared for as his hometown looks. Suggested raising taxes or fees if more money is needed to run the yard debris program and doing away with bagging the leaves.

Kim Northcutt, 911 Hannah Avenue: suggested more yard debris rollcarts are needed and each home needs more than one rollcart.

Seth Lowe, 131 Loring Drive: expressed concern for elderly citizens unable to afford to hire lawn care companies or who do their own yard work.

Randy Lowe, 1111 West Carolina Avenue: willing to pay more for the service to not deal with the brown rollcarts and bagging leaves. Encouraged Council to find another way to deal with the issue.

### Yard Debris Discussion

City Manager Moore provided information and background on the recent changes to the yard debris service. The brown rollcart pilot program received positive feedback, so we moved forward. The amount of yard debris City picks up far exceeds the garbage tonnage. The program is time consuming and equipment is tearing up. Many options discussed to continue offering a good level of service. Staff currently has a waiting list for free rollcarts and is giving out bags for free for one year. There is a one-year grace period with no penalties while the changes are implemented. We are hopeful changes to the yard debris program will keep leaves out of storm drains and allow the City to continue providing this service to citizens.

Councilmember DeLaine encouraged citizens look at overall issue, how it impacts the community and to give the new program a chance. Other cities have been bagging leaves for many years. We can reevaluate the program in the future. Reminded everyone there is no penalty for not raking leaves.

Councilmember Caldwell reminded everyone the yard debris program can be revisited in the future.

Councilmember McGee hopes the change acts as a catalyst for citizens thinking how we can use leaves as mulch or other alternatives to sending them to the landfill.

Mayor Pro Tem Andrews thanked everyone for their input. Councilmembers live in the community and rake leaves too. Democracy is not dead in Hartsville. All councilmembers will be looking to see how implementation goes.
