<u>Center Theater Update – Monty Bell & Kim Cranford</u>

Monty Bell, Commissioner on Center Theater Building Commission, gave an update on the Center Theater building renovation plans, timelines, and the associated financials. Renovation of the building is

a significant project with a broad scope requiring strategic planning and utilizing many skill sets. Initially, the leaking roof and exterior walls had to be addressed by installation of new roof membrane and mortar joint replacements. Those repairs as well as the new heat/cooling system and electrical upgrade are complete. The interior renovation will include painting the theater and installation of new seating, upgraded lighting, a state-of-the-art sound system and an elevator. Interior renovations are expected to begin in July of 2023 and are estimated to take approximately four to six months to complete. After renovations the theater will seat 900, making it the fifth largest theater in the state, and be ADA compliant. The Commission envisions bringing larger, more detailed productions and events downtown when it reopens in mid-winter 2023. The Commission is requesting the community's continued support to raise the remaining \$1.6 million needed to complete the renovation project.

The first concert of the season is the Pre-Mother's Day Celebration on Sunday, May 7th from 5pm to 8pm. Council received the 2023 schedule for the monthly concerts held at Pride Park. Everyone invited to the free concerts and organizers are looking forward to a successful 2023 season.

Mayor Hancock explained population changes reported after the 2020 Census show population variances among some of the City Council Districts. Staff worked with SC Revenue & Fiscal Affairs Office and Darlington Voter Registration to balance out the population more evenly across the City Council
