1. CALL TO ORDER AND WELCOME

Board Chair, Kat Davis, called the meeting to order at 5:37p.m. and welcomed all in attendance.

2. APPROVAL OF MINUTES FROM PREVIOUS MEETING

Baker made a motion to approve the minutes from the previous meeting, with a second from Wheeler. No discussion or amendments were made. Motion approved by all.

3. MAIN STREET MANAGER UPDATE

Winburn reported that the last Chats and Cheers event was a huge success with the biggest takeaways are better communication with our downtown businesses, especially with upcoming events.

Winburn gave an update on the Cultural District Steering Committee, which is a Main Street Hartsville initiative, and reported that everyone was excited to help make sure our arts and cultural assets remain relevant and lively in Downtown Hartsville.

Winburn reported that the first Farmers Market of the season would be held on May 13th and that anyone looking to volunteer should plan to arrive at 7:30am.

Finally, Winburn reported that Main Street Hartsville is exploring a streets sound system to bring streamed music downtown. Expanding wi-fi downtown is also being investigated.

4. **NEW BUSINESS**

a. APPROVAL OF CULTURAL DISTRICT RESOLUTION AND BOUNDARIES

Verbiage and image of the proposed Hartsville Cultural District was presented to the Main Street Hartsville Advisory Board for approval before being sent to Hartsville City Council. A motion was made by Wheeler to approve the verbiage and district boundaries; seconded by Baker. Motion carried.
