# **Proclamations**

- 1. Mayor Hancock presented the Juneteenth proclamation to Barbara Carraway, Adlena Graham, and Rev. Jim Blue encouraging all citizens to become more aware of the significance of African American history and in the heritage of our nation and city.
- 2. Mayor Hancock presented the Men's Health Month proclamation to Barbara Carraway with Darlington County First Steps, Michael Northcutt of Carolina Pines Regional Medical Center, and Patricia Sullivan of SC Cancer Alliance for Healthy Communities. An announcement was made that free screenings will be held at Pride Park on 7/9/23.

### **Public Comments**

 Marie Conrad – 832 Hillcrest Road, Hartsville, SC asked that something be done about the truck traffic on Sixth Street. They are speeding and it is not safe, especially since the Boys and Girls Club and Pride Park are on that corridor. The street is not wide enough for this truck traffic. Barbara Carraway and Rev. Jim Blue joined Ms. Conrad in her concerns. Mayor Hancock explained that the city is exploring design and traffic calming measures. 2. Dan Askins – 555 Lakeshore Drive, Hartsville, SC is looking for ways to build a bridge in our community and suggests that Byerly Park is a place where things are happening and would be a great place for food trucks, which bring community together.

PUBLIC HEARING AND FINAL READING ORDINANCE 4454 - TO AMEND THE WATER AND SEWER RATE STRUCTURE IN ACCORDANCE WITH SECTION 82-176(A) OF THE HARTSVILLE CITY CODE — APPROVED. Open/Close Public Hearing (state name and address for record) — Patricia Wingate, 431 Logan Avenue asked if any new installations would occur on Logan Avenue since they are having trouble with their lines.

Councilmember Mack explained that a grant would cover some streets and we would have to see which streets were included.

PUBLIC HEARING AND FINAL READING ORDINANCE 4455 - AN ORDINANCE TO ADOPT A BUDGET FOR THE CITY OF HARTSVILLE, SOUTH CAROLINA, FOR THE FISCAL YEAR BEGINNING JULY 1, 2023, AND ENDING JUNE 30, 2024 – APPROVED.

Open/Close Public Hearing (state name and address for record) – None.

City Manager Moore had previously highlighted a balanced budget that includes no tax increases, revenues up eighteen percent, includes five percent cost of living adjustment for employees and the proposed salary increases after the compensation study brings all employees up to a livable wage. The combined twenty-seven-million-dollar budget includes two-million four-hundred-thousand dollars in capital improvements with police vehicles, a fire truck and a garbage truck.

# **NEW BUSINESS**

RESOLUTION 06-23-02: APPROVAL OF DISTRIBUTION OF STATE-LOCAL ACCOMMODATIONS TAX REVENUE – APPROVED.

City Manager Moore explained that the A-Tax Committee had done a fine job with their recommendations for the disbursement of these funds.

Motion: Andrews; Second: Caldwell; Carried: All ayes.

RESOLUTION 06-23-03: APPROVAL FOR COLLABORATIVE AGREEMENT BETWEEN THE CITY OF HARTSVILLE AND PEE DEE REGIONAL TRANSPORTATION AUTHORITY FOR PUBLIC TRANSIT SERVICES - APPROVED.

Councilmember Mack expressed the importance of keeping these services available without cost to riders.

RESOLUTION 06-23-04: DESIGNATING A SECTION OF DOWNTOWN HARTSVILLE AS A SOUTH CAROLINA ARTS COMMISSION CULTURAL DISTRICT - APPROVED.

Mayor Pro-Tem Andrews noted that the city will keep an internal expansion map of some historic areas not currently included for potential future expansion. City Manager Moore explained that new signage will be erected and within five years the district will be reviewed for expansion. Councilmember Mack noted that South Hartsville has historic areas that are not included.

RESOLUTION 06-23-05: APPROVAL FOR THE CITY OF HARTSVILLE POLICE DEPARTMENT (HPD) TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE SOUTH CAROLINA LAW ENFORCEMENT ACCREDITATION, INC. (SCLEA) FOR STATE ACCREDITATION - APPROVED.

RESOLUTION 06-23-06: APPROVAL TO NAME THE HARTSVILLE REGIONAL AIRPORT TERMINAL BUILDING FOR THE HONORABLE SENATOR GERALD MALLOY – APPROVED.

Councilmember Mack explained that Senator Malloy acquired \$500,000 plus for the current terminal building.
