# Griggs Circle Bakery - 116 N. Fifth St. - replacing awning.

# Sonoco Products Company - 201 N. Fifth St. - mural

Becky Skipper was present to participate in the discussion regarding an application she submitted for a mural. The mural could not be approved as submitted because it displayed a commercial message. According to the mural ordinance a commercial message is considered a sign and is subject to the sign ordinance. Commercial messages would follow the sign regulations. Mrs. Skipper stated Sonoco's intent and purpose of the mural. Staff and the board offered ideas for a revised mural. Mrs. Skipper will use the ideas to work with the artist to provide a new rendering. No action was taken.

- On Thursday, July 20, 2023, Main Street Hartsville and City staff will be giving a tour of Downtown Hartsville to representatives from the SC Arts Commission. This tour is a requirement in the process to become a certified SC Cultural District. Hartsville would become the 11<sup>th</sup> Cultural District in SC. Cultural Districts are meant to be a tool for economic development and to increase foot traffic in a city's downtown area. This program would be managed by Main Street Hartsville with support from the City of Hartsville and Black Creek Arts Council.
