UNFINISHED BUSINESS

PUBLIC HEARING AND FINAL READING ORDINANCE 4456: AN ORDINANCE AMENDING AND RESTATING CERTAIN PROVISIONS OF THE CITY OF HARTSVILLE CODE WITHIN CHAPTER 2, ARTICLE IV DIVISION 4

SECTION 2-376 FOR PARKS COMMITTEE - APPROVED.

Reading by Title and Presentation – Assistant City Manager Caulder approval expands the role of the current Parks Committee to include recreation activity. This change was proposed by the Parks Committee.

NEW BUSINESS

RESOLUTION 08-23-01: APPROVAL FOR TRANSFER OF CEMETERY REVENUE TO PERPETUAL CARE INVESTMENT TRUST FUND – APPROVED.

Assistant City Manager Caulder explained this approves the annual transfer of funds for perpetual care of the City cemeteries.

RESOLUTION 08-23-02: A RESOLUTION APPROVING THE DISSOLUTION OF THE HARTSVILLE PUBLIC DEVELOPMENT CORPORATION, AND OTHER MATTERS RELATING THERETO - APPROVED.

Assistant City Manager Caulder informed Council the HPDC board approved the dissolution last week. The transfer of the properties from HPDC back to the City facilitated the dissolution of the HPDC. Motion: Andrews; Second: Caldwell; Carried: All ayes, with the exception of McGee voting nay.

RESOLUTION 08-23-03: APPROVAL TO DESIGNATE THE CITY OF HARTSVILLE TO BE A BEE CITY USA AFFILIATE - APPROVED.

Mayor Hancock explained the City already meets most of the requirements for the Bee City USA designation. Thanked the citizens for bringing it to our attention.

RESOLUTION 08-23-04: TO EXPRESS THE INTENTION OF THE CITY COUNCIL OF THE CITY OF HARTSVILLE, TO CAUSE THE CITY OF HARTSVILLE TO BE REIMBURSED WITH THE PROCEEDS OF OBLIGATIONS FOR CERTAIN COSTS ASSOCIATED WITH THE LEASE PURCHASE OF CERTAIN VEHICLES, EQUIPMENT AND RELATED IMPROVEMENTS- APPROVED.

Assistant City Manager Caulder advised this resolution approves reimbursement with funds from a capital lease purchase for a trash truck, fire truck and police vehicles. These items were approved in the budget. The resolution allows the City to proceed with the purchase and reimbursement from the capital lease purchase.

RESOLUTION 08-23-05: AUTHORIZING THE CITY OF HARTSVILLE TO ADOPT AN ASSESSMENT AND APPEALS POLICY FOR THE ADMINISTRATION OF THE CITY'S BUSINESS LICENSE PROGRAM; AND OTHER MATTERS RELATING THERETO – APPROVED.

Assistant City Manager Caulder stated approval is needed to clarify the procedure currently in place for business license assessments and appeals.

RESOLUTION 08-23-06: APPROVAL OF AN ADDENDUM TO THE INTERJURISDICTIONAL AGREEMENT WITH ALLIGATOR RURAL WATER AND SEWER COMPANY FOR WASTEWATER TREATMENT SERVICES – APPROVED.

Public Services Director Bethea explained that currently the City handles wastewater service for major industries in McBee from Alligator Rural Water and Sewer. The new DHEC inspector requires an additional enforcement clause in the current contract.

RESOLUTION 08-23-07: APPROVAL OF A MEMORANDUM OF AGREEMENT BETWEEN SOUTH CAROLINA DEPARTMENT OF JUVENILE JUSTICE'S DETENTION CENTER (SCDJJ) AND THE CITY OF HARTSVILLE FOR THE PURPOSE OF HOUSING YOUTH AT THE STATE'S DETENTION CENTER IN COLUMBIA, SOUTH CAROLINA – APPROVED.

Interim Police Chief Snellgrove explained all the police departments in the state use DJJ to house juveniles and agree to pay per person per night for housing.

Assistant City Manager Caulder further explained this is an annual renewal of the agreement with SCDJJ. Motion: McGee; Second: Mack; Carried: All ayes.

RESOLUTION 08-23-08: TO PROVIDE FOR THE AMENDMENT OF FEES THAT ARE NECESSARY FOR THE OPERATION OF THE CITY OF HARTSVILLE – APPROVED.

Assistant City Manager Caulder approval updates the fees for use of City facilities at the Hartsville Airport.
