Project Team

Project Understanding

The primary goal of this project is to replace the existing Piratesville Splashpad at Neptune Island Waterpark with new, durable amenities such as spray features, a climbable play structure, dumping buckets, and slide(s) that provide long-lasting play value for users of all ages while in budget.

A highly desired component of the project is maintaining the existing splash pad footprint which will be appropriately explored and considered. The existing mechanical treatment system will be evaluated for re-use in an effort to maximize the use of the budget for splash pad features. In addition, the project team will evaluate options to streamline design, feature procurement, and complete construction before opening day, May 24, 2024.

- iii. Removal / demolition of existing facilities will occur upon agreement of project team and ownership. Likely to occur prior to final GMP execution. Initial budget/negotiations will include this cost.
- iv. Limited demolition of existing building and Mechanical/Electrical/Plumbing services.
- v. New plumbing and controls to be installed for all new splash pad features.
- vi. Multiple training sessions to confirm operation of pump room equipment as well as care and maintenance of new features.

Schedule

The following schedule reflects a range of possible completion dates. These dates will be confirmed at the conclusion of the Concept Development Phase. We recognize that it is the Owners preference to complete this work prior to the 2024 season and understand that under no circumstances can the splashpad be under construction during the operating season. Completion of the project prior to the 2024 season is very aggressive and leaves limited time

for Owner decisions, fundraising, and review. Should the project scope grow beyond the previously stated assumptions and require additional design time, construction will likely be completed following the 2024 season and prior to the 2025 season.





Across from the tot splash pad is a 6,321 SF zero-depth entry family activity pool with ten geysers, a kiddie slide, and three-sided basketball hoops in the 4' deep end. For those interested in relaxing, the activity pool is surrounded by mini cabanas and relaxing pool chairs just feet away from snacks and beverages from the nearby restaurants.

In the center of Carolina Splash is the star attraction, a 11,185 SF wet deck with a multi-level interactive play structure. Vibrant seaside murals, palm trees, smiling suns, and pelicans decorate the citrus-colored sprawling play structure. The play structure features activities for all ages and includes numerous spray features, geysers, bridges, five runout slides, and an enormous 350-gallon dumping bucket.



Dozens of children, of all ages, gathered under the interactive features for the inaugural activation of the water sprays at Reindahl Park. The spray ground is free and open to the public throughout summer months.

WTI was hired in 2013 by the City of Madison for the design and engineering of the Reindahl Park Splash Pad, support/concessions building, and Shade Shelters. Through a series of public and staff meetings, WTI developed the design for the new splash park. The 2,200 Square Foot splash pad is designed into three connecting spray zones, each appealing to a slightly different age group. Adjacent to the splash pad are shade shelters, designed by WTI, which house 2-4 picnic tables and a mechanical support/concessions building. Uniquely, a remote monitoring system connects to the splash pad for the convenience of the Madison Park Maintenance department to keep an eye on the mechanical systems.

Other improvements expected to take place at the park over the course of five years include athletic facility enhancements and new shelter landscaping. The park is also home to a major soccer complex, reservable shelter, playground, basketball court, community gardens, and tennis courts.

H2O'Brien Pool suffered from decreased attendance within the last seven years of its life. The city quickly recognized the aging of the facility and the prominent need of improvements and repairs. Water Technology, Inc. (WTI) was hired as the consultant alongside the architect of record, Barker Rinker Seacat to restore this beloved community pool.

Taking into consideration the existing site, the design team was faced with the challenge of ensuring that the footprint of the new play structure, deemed the best fit for the specific requirements of the existing structure, fit within the blueprint of the existing pool. After careful consideration, a hybrid Kaledioscope and Grasslands Activity Tower were selected. The design process was seamless thanks to Waterplay Interactive Concept Designer, an advanced planning tool that was used between the design team and Town Officials to collaboratively decide on design elements.

The \$2.8 million renovation consisted of the new Activity Tower with two tot slides that features several interactive play features such as a Sky Soaker (Dumping Bucket), Waterfall 2, Water Weaver 3, Aqua-Knot, Funbrella, Misty Twisty, and more creating the ultimate universal play experience. A leisure pool with zero-depth entry and 4-lap lanes provides opportunities for all users regardless of age.

After a quick turnaround, with the renovations completed during the off-season, the H2O'Brien was set to open Memorial Day Weekend 2020, however, COVID-19 Pandemic delayed the opening until July 2020.

"It's been packed pretty much nonstop," said Bryan Gentilini, the town's recreation supervisor for aquatics. "As soon as it hit the 80s, it's been packed every day."
