Updates – **Received as information only:** Executive Director McElveen presented to the Board the February financials for General Fund and Section 8.

Public Housing Updates: As of February 28, 2017. The Delinquency Report Rating was at 97.96%. The Public Housing Waiting List stands at 14 applicants. Move-outs: 1. Move-ins: 2: Occupancy Rate: 97% Tomika Berry is working on a No Smoking Policy which is mandatory by HUD as of July 2018.

Section 8 Updates: As of February 28, 2017. The Delinquency Report Rating was 98.11%. The Waiting List stands at 76 applicants. Move-outs: 2. New admissions: 0. Occupancy rate: 158.

Administration: The audit for fiscal year end 09/30/2016 is scheduled for the week of April 17, 2017.

New Business:

- 1. Discussion of a web site designer for the Housing Authority of Hartsville. Director McElveen presented the information from Scott Accounting & Computer Service (SACS) and Brooks-Jeffrey. Brooks-Jeffrey has been very instrumental is designing web sites for housing authorities. The Darlington Housing Authority's web site was designed by Brooks-Jeffrey. Director McElveen demonstrated the different aspects of the web site. SACS sent a quote upon request but did not follow up with the Housing Authority. They did not show interest like Brooks-Jeffrey did.
- 2. Discussion of a bank for Section 8 program Checking and Money Market Accounts. Director McElveen explained that the Housing Authority of Hartsville (HAH) has three accounts, General Fund (A/P & Payroll), Section 8 checking (pay landlords/property owners) and a Section 8 money market at Wells Fargo. Director McElveen inquired regarding direct deposit for landlords/property owners the individual at Wells Fargo was not at all helpful. Was told to go online and look at the options. Director McElveen went to Heritage Bank and inquired about opening a business checking account. The individual gave a one page breakdown of the different account options. Did not spend no more than five minutes at Heritage. Stopped at First Citizens Bank. The individual was very friendly and asked numerous questions. Spent about 30 minutes at this bank. The bank submitted a very professional proposal. The last bank was South State Bank. Talked with an individual. An employee with the business sector contacted the Director by phone and submitted a two page proposal by email. The commissioners agreed that First Citizens was the most professional of all the banks. Commissioner Bachman recommended we give Heritage Bank a second chance due to the fact that they are the only "hometown bank" out of the group. Commissioner Lunella Williams and Commissioner Ted Williams agreed and asked Commissioner Bachman and Director McElveen to meet with Heritage Bank and get a better proposal. The board will meet again and decide between Heritage Bank and First Citizens Bank.
- 3. Discussion of a bank for General Funds (A/P and Payroll) was rolled into Discussion 2.
- 4. Discussion of setting up direct deposit to pay Section 8 landlords/owners will depend on the outcome of Discussion 2.

Res.1129-to approve a web site designer for the Housing Authority of Hartsville. Brooks-Jeffrey was chosen as the web site designer. After a brief discussion a motion was made by Commissioner Ted Williams and seconded by Commissioner Lunella Williams to approve Res 1129 the approval of Brooks-Jeffrey as the web site designer for the Housing Authority of Hartsville.
